Chapter 32C. North Carolina Uniform Power of Attorney Act ...

(1) A power to the extent it is coupled with an interest in the subject of the power, including a power given to or for the benefit of a creditor in connection with a credit transaction (2) A power to make health care decisions (3) A proxy or other delegation to exercise voting rights or management rights with respect to an entity

Your Right to Make Decisions About Medical Treatment

POWER OF ATTORNEY FOR HEALTH CARE lets you name an agent to make decisions for you Your agent can make most medical decisions - not just those about life sustaining treatment - when you can't speak for yourself You can also let your agent make decisions earlier, if you wish
