Competition Law In Argentina

2018, the President of Argentina enacted a new competition law [2] which entails a major overhaul of the competition law regime in Argentina. The bill that led to the enactment of Law No 27,442 (the “New Competition Law”) was introduced by the governing party and has received the feedback
