Concerning the Public Records Act Model Rules In 2005, the state legislature directed the Attorney General to adopt advisory "model rules" for state and local agencies⁶ These Model Rules are now published in the Washington Administrative Code at chapter 44-14 Though the current version of the Model Rules deals mostly with disclo-
